Uzinei, No. 1, announces to the interested public that on 17.11.2022, at the headquarters of the Vâlcea Environmental Protection Agency, Strada Remus Bellu, no. 6, Râmnicu Vâlcea, Et. 1, Room No. 9, starting at 2:00 p.m., the public debate session on the documentation regarding the request to obtain the integrated environmental authorization for CHIMCOMPLEX S.A. takes place. BORZEŞTI SUCURSALA RAMNICU VALCEA, for carrying out the activities that fall under annex no. 1 of Law no. 278/2013 on industrial emissions, points:

- 1.1. the burning of fuels in installations with a total nominal thermal power equal to or greater than 50MW
 - 3.1.b) lime production in kilns with a production capacity of over 50 tons per day;
- 4.1.b) hydrocarbons containing oxygen, such as alcohols, aldehydes, ethers, peroxides (oxo-alcohols, dioctyl phthalate, propene oxide, propylene glycol, polyols, polyethers, hydrogen peroxide);
 - 4.1.f) halogenated hydrocarbons (dichloropropane);
 - 4.2. Production of inorganic chemical compounds, such as:
 - a) gases, such as chlorine or hydrochloric acid (membrane electrolysis);
 - b) acids, such as hydrochloric acid (Electrolysis with membranes);
 - c) bases, such as sodium hydroxide (Electrolysis with membranes, Soda block, flakes, pearls);
 - 5.2. Waste disposal or recovery in waste incineration facilities;
- b) in the case of hazardous waste, with a capacity of more than 10 tons per day (Krebs and Vichem Installations)
- 5.4. Waste depots, which receive more than 10 tons of waste per day or with a total capacity of more than 25,000 tons the disposal of non-hazardous waste.
