

PUBLIC NOTICE

on the request for the issuance of the integrated environmental permit

"CHIMCOMPLEX S.A. BORZESTI - RAMNICU VALCEA BRANCH based in Valcea county, Ramnicu Valcea locality, Uzinei street, no. 1, announces the submission of the application for obtaining the integrated environmental permit in order to carry out the activities in:

- Ramnicu Valcea locality, Uzinei street, no.1;
- Ramnicu Valcea locality, Priza Olt;
- Ramnicu Valcea locality, Stolniceni street (Non-hazardous waste landfill);
- -Valcea county, Mihaiesti commune, Stuparei village (Biological Treatment Plant):
- -Valcea county, Babeni town, Tatarani village (Bistrita catchment drinking water supply system); The activities are included in annex no. 1 of Law no. 278/2013 on industrial emissions, at the following points:
- 1.1. Combustion of fuels in installations with a total thermal power equal to or greater than 50 MW;
 - 3.1.b) production of lime in ovens with a production capacity of over 50 tons per day;
- 4.1.b) oxygen-containing hydrocarbons, such as alcohols, aldehydes, ethers, peroxides (oxoalcohols, propenoxide, propylene glycol, polyols, polyethers);
 - 4.1.f) halogenated hydrocarbons (dichloropropane);
 - 4.2. Production of inorganic chemical compounds, such as:
 - a) gases, such as chlorine or hydrochloric acid (Membrane electrolysis),
 - b) acids, such as hydrochloric acid (Membrane electrolysis);
 - c) bases, such as sodium hydroxide (Membrane electrolysis, block soda, flakes, pearls);
 - 5.2. Disposal or recovery of waste in waste incineration plants
- b) in case of hazardous waste, with a capacity of over 10 tons per day (Krebs and Vichem Installations);
- 5.4. Landfills, which receive over 10 tons of waste per day or with a total capacity of over 25000 tons - non-hazardous landfill.

The request for the issuance of the integrated environmental permit refers to the existing installations in operation.

The information regarding the potential impact on the environment of the activity for which it is requested to obtain the integrated environmental authorization can be obtained from the headquarters of the Agency for Environmental Protection Valcea, Remus Bellu street no. 6, Ramnicu Valcea, daily from Monday to Thursday, between 800-1630 and Friday between 800-1400.
