of at least 27 MW and a total thermal power of at least 26.10 MW, with three identical units, within the project "High-efficiency gas cogeneration, flexible, in the centralized heating sector of Râmnicu-Vâlcea" ("The Project"), a project funded under the NATIONAL RECOVERY AND RESILIENCE PLAN, Component Energy, Investment Measure 3 - Development of flexible and highly efficient gas production capacities for cogeneration of electricity and heat (CHP) in the centralized heating sector, in order to achieve deep decarbonization, Project Call Supporting Investments in High-Efficiency Cogeneration in the Centralized Heating Sector under the financing agreement no. 4 / 26.01.2023 concluded with the Ministry of Energy as the coordinator of reforms and/or investments for NRRP - Component 6.
